SYNTHETIC MOCK. This file imitates the layout of a public docket search so the sample can show the reconciliation step. It is not output from CourtListener, PACER or any court portal, and every court, case and entry in it is invented. In a live engagement this step is a CourtListener search of RECAP dockets and opinions, plus any public state e-court portals, with the search terms and date recorded.
